In preparation for the **2020** centennial celebration of the passage in **Tennessee of the 19th Amendment**, League members are reading **The Woman's Hour** by Elaine Weiss about how women won the right to vote. We are organizing book groups to discuss this dramatic history. Please plan to take part.

**State Advocacy Update**

This was quite a legislative session and our volunteers were engaged as never before. Without a doubt the

most significant bill that impacts **LWV** directly was the passage of **SB971/HB1079**. It will create a chilling effect on voter registration drives in the state and our print and online communications with voters.

Despite our multiple **action** alerts, our **testimony** in committees, our **meetings** with legislators, our **letters** to the editor, and our **letters** to the governor, an amended version of the bill **passed** and was immediately signed into law by the governor. It is scheduled to go into effect **October 1, 2019**.

As a result, **LWVTN** along with four other plaintiffs impacted by this legislation, **Rock the Vote**, **American Muslim Advisory Committee**, **Mid-South Peace and Justice Center**, and **Spread the Vote**, filed a federal lawsuit against the state. We will be represented by **ACLU**, **Campaign Legal Center**, and **Fair Election Center**. See our full press release for more details.



### **Tennessee's 1919 Limited Suffrage Bill** **By State Advocacy Chair Debby Gould**

It may come as a surprise to many of you that **1919** saw a **limited** suffrage bill pass the legislature allowing Tennessee women to vote in municipal elections. What better way to honor this event than to urge Nashville's women to vote in the Metro elections on **August 1**? We will be working hard this summer to encourage voter participation and to promote the use of our voters guide <http://www.vote411.org>.

Stay tuned as well for announcements of an **LWV** book club this summer to discuss **The Woman's Hour**. This book provides fresh insights into Tennessee's pivotal moment in Suffrage history. ### **Legislation Requires Trauma-Enforced Disciplinary Policies Across the State** **By Vice President Clare Sullivan**

A bill sponsored by **Representative Harold Love Jr.** (Davidson County) and **Senator Katrina Robinson** (Shelby County) was passed in the General Assembly this session. This bill requires each local education agency and public charter school in the state adopt a trauma-informed disciplinary policy. The bill directs the Tennessee Department of Education to develop guidance on trauma-informed disciplinary practices that local education agencies can use in their own policy development. Key principles intended by the legislation to be reflected in new disciplinary policies include the following:

- Balances accountability with an understanding of traumatic behavior;
- Teaches school and classroom rules while reinforcing that violent or abusive behavior is not allowed at school;
- Minimizes disruptions to education with an emphasis on positive behavioral supports and behavioral intervention plans;
- Creates consistent rules and consequences;
- Models respectful, nonviolent relationships.

The original version of the legislation specifically mentioned the need for an **Adverse Childhood**

**Experiences** assessment before suspending, expelling, or requiring a student to attend in-school suspension or alternative school. However, the specific reference to an ACEs assessment was eliminated from the final bill.

## **TennCare Block Grant Legislation Awaits Governor Lee's Signature or Veto** **By Vice President Clare Sullivan**

The controversial Block Grant legislation mandates the state to submit yet another TennCare waiver to the **Centers for Medicare and Medicaid (CMS)**. This waiver would permit CMS to provide a **fixed** amount of block grant funding for TennCare in return for allowing the state "flexibility" from the rules that apply to Medicaid programs in 49 other states. It is now sitting on Governor Lee's desk awaiting his signature.

While he is expected to sign it, calls to his office are still appropriate to alert him to the fact that **League of Women Voters** members do not see how **limiting** funding for a needs-based program will be in the state's best interest. If he chooses not to veto it *now*, we will join those advocates monitoring the resulting waiver proposal, and hold him to his promise to reject it *later* when it turns out it will *not* to be in the best interests of Tennessee children, families, elders and disabled who depend on TennCare for services.



## **Notes from May Hot Topic: Landfills and Quarries: Patterns of Environmental Injustice** **By Debby Gould**

**Dr. David Padgett**, associate professor of geography at TSU, gave us a new and deeper understanding of environmental injustice for our May hot topics programs, "**Landfills and Quarries: Patterns of Environmental Injustice**". Using geographic and health data from Nashville and middle Tennessee, he illustrated the ways that urban eyesores disproportionately impacted African American communities and how their rehabilitation and cleanup as brown fields has created gentrified pockets of development that often don't enhance the lives of residents in the surrounding neighborhoods. He also highlighted the lack of recycling centers in areas of the city such as the area near TSU as another inequitable distribution of community resources that impacts the North Nashville community.

**Voter Services Update for May 2019**

After a deeply dispiriting session of the **Tennessee Legislature**, we turned our attention to the Davidson County Election Commission (DCEC) and to the opportunities we have for voter education and registration this summer. DCEC has significant challenges, both internally and externally, as it prepares to utilize **new** voting machines for the **August 1** election. With no funding available for education and with trained poll workers stretched thinly throughout the county, Commissioners and Administrator **Jeff Roberts** are understandably concerned about how smoothly the **August 1** election will run. Thanks to a longstanding relationship with **LWVN**, particularly with Voter Services stalwart **Debby Gould**, DCEC has agreed to allow us to take a few of the new machines into community meetings for demonstration and education purposes.

At its May meeting, **DCEC** commissioners and staff spent considerable time discussing its response to a request from Metro Council for feedback on the proposed amendment to the **Metro Charter** concerning **rank choice voting**. As currently drafted, the **Amendment** would **limit** the rank choice voting to the top 5 candidates. It would be implemented in **2023**. With very little hard data available on the experience of rank choice voting (Maine is the only state to have implemented it statewide) it seems that the only concurrence on the issue is **"There are a lot of unanswered questions."**

We are beginning to receive requests for voter registration events, so look for our invitations to join us in this most **fundamental** of our efforts. Community meetings for the At-Large Metro Council candidates are also under discussion. Stay tuned!

Finally, from one Co-Chair to the other: **Hazel**, we **commend** and **thank you** for your years of contribution to **LWVN** and to the **State League** on behalf of **Voter Services**. Your quiet dedication and commitment have contributed significantly to the League's presence and participation at many levels. Best wishes in your new North Carolina home!



## Update on Environment Bills at the General Assembly By Environment Chair Barbara Futter

It has been a wild crazy session this year. But that doesn't mean there isn't good news! The good environmental news is that there were **no** significant or devastating **defeats!** Working with our partner **Tennessee Conservation Voters (TCV)**, **LWV** members became informed and very active. Here are things to celebrate.

**Utility Round Up** programs: Round up programs by local utility companies help low-income residents get weatherization and energy efficiency aid and other positive benefits. Opt-out programs are a step toward responsible energy policy. The sponsor tried to outlaw these programs even if they were locally supported. Thanks to widespread concerns from citizens and utilities, the bill that became law allowed existing programs to continue. But, they must notify customers in writing that they have the option of choosing not to participate. New programs may be started up until December 31, 2020. After this date, programs will only enroll customers who choose to participate in the round up programs. In **January, 2019**, Nashville's Metro Council decided **not** to have an opt in program, but with this amended bill Metro could still pass opt out. At present, you can choose to participate if you want.

**Plastics!!** Local governments may not regulate plastics or other one-time use items. A last-minute surprise amendment to a general boundary bill made it **illegal** for cities to regulate, prohibit or charge fees for single-use pollutants (aka plastics.) We **opposed** this bill since it would preempt local communities from instituting any controls on single use plastic containers and bags. We didn't like the state's over reach into local communities decisions. We will continue to be active on this issue and find areas to advocate for reduce plastic use. (Talk to stores where we shop, to companies that produce items and to our schools too.)

Here are some good results!!

**Open TVA board meetings:** Please thank **Senator Yager** for sponsoring a resolution that asks Congress to **require** all board committee meetings of the **TVA Board of Directors** to be open to the public. We support open government and this was a strong step.

Lastly, **Senator Yarbrow** and new **Representative Freeman** showed strong leadership in their bill to create an advisory task force on **Community Resilience**. This task force would review our state's response to extreme weather and natural disasters to assess Tennessee's vulnerabilities. The bill was sent to TACIR (the state agency that researches and studies intergovernmental issues) to be studied in more detail. We will continue to monitor this important bill, (which may well be acted upon next year.)

As you can see, there was not as much damage as we feared. Thank you for your diligence and hard work. We partner very closely with **TCV** to monitor bills so that our members can be informed and active in legislative work. Enjoy the environment and the outdoors this summer!!

## **Vouchers in Tennessee**

Late in April, the **General Assembly** passed **HB 939/SB 795** paving the way for a voucher program in Tennessee that applies **only** to Davidson and Shelby Counties. There is still much that seems up in the air about the bill, and lawsuits are forthcoming. As of the writing of this newsletter, the law has not been sent to Governor Lee. There is a federal investigation around this legislation reportedly about whether or not campaign donations were promised for “Yes” votes.

One of the things that we can do as LWVN members can do is to **pay** attention to how the program is implemented. We will continue to monitor and report findings. For further reading on vouchers, here are some links:
