
In addition, absentee voting in Tennessee is available to **anyone** who wishes to do so. However, there are steps involved in **applying** for an absentee ballot, **receiving** one, and then **returning** it by mail. Timing is everything. Aim to mail your ballot on or before **July 20**<sup>th</sup> to ensure that the Davidson County Election Commission receives it in time. ## June 2020 Financial Report By Treasurer Susan Mattson

The League of Women Voters of Nashville ended its fiscal year 2019-20 in good financial position. As of June 30, 2020, the LWVN accounts totaled close to \$56,000. FY 2019-20 income was \$30,000 (99% of budgeted) and expenses were \$22,200 (59% of budgeted). LWVN had a net income of \$7,604. Membership dues for 2020-21 are coming in strong. We are in a good position to continue and expand our programs and services in 2020-21.



# Summary of July Hot Topic - Facing Challenges and Changes in the 2020 Election Cycle

On Friday, July 10, 2020, **Jeff Roberts**, Administrator of Elections for Davidson County, was the guest at the Hot Topics on Zoom. **Debby Gould** introduced and moderated the event and a total of 57+ interested people attended on the Zoom platform.

**Roberts** began stressing that all polling sites at all 160 locations will be open on **August 6<sup>th</sup>**, and all sites will be following guidance protocols pertaining to Covid-19. The sites will be cleaned and sanitized. **All** poll workers and officials will be masked and wearing protective equipment. Social distance will be in place. Entrance into the polling site will be controlled to eliminate any potential for overcrowding. Voters will be using voting sticks for touchless voting and will be expected to wear masks. If a voter doesn't have a mask, one will be offered.

Because of the need to maximize space in polling sites to protect voters and workers, there will be **fewer** poll workers per site. So far, there have been **250 applications** to become a poll worker since June, so Roberts believes that Davidson County will have enough capacity to cover all **160 sites** on Election Day.

Early voting begins July 17<sup>th,</sup> and, on that day **all** 11 sites will be open. Early voting sites will also follow the same protocols listed above.

At both early voting polling sites and Election Day polling sites, lines outside the site may **appear** to be long. However, because of the six-feet distance to be maintained between voters in line, it is important to recognize that these lines will be moving quickly.

On the critical issue of **absentee voting**, Mr. Roberts shared a great deal of important information. Essentially, because of Chancellor Lyle's court ruling, **anyone** is eligible to vote absentee. Roberts and the Davidson County Election Commission are trying to get this information out to the public and will continue to do so. He also asks that the public and the media help with this communication in print, social media, and on air.

So far, the Davidson County Election Commission has received **21,000 requests** for absentee ballots. At this time in the August 2016 election, it had received only 1700 requests. The Election Commission is anticipating **50%** of the voting public will vote absentee in the August election. As a result, it has hired more people to handle the volume and purchased a \$50,000 scanner to count votes.

It is important to know that at 7 a.m. on Election Day, the **sealed** boxes of absentee ballots will be opened and handled in the presence of both Democrat and Republican representatives to ensure that all is fair and just. Given the length of time needed to count absentee and provisional ballots, election results may be delayed.

This was the night telegram sent by Carrie Chapman Catt (aka the Chief) by way of the hotel switchboard at the Hermitage to the National American Woman Suffrage Association (NAWSA) headquarters in New York. A powerful and prophetic three sentence message...to her colleagues then and for us now.

It seems fitting in so many ways that, as we cautiously begin to personally register, assist, and educate voters, we launch these efforts just a few miles from the Hermitage Hotel. On Saturday, July 18 we will join an outdoor event at the Jefferson Street Sound Museum from 11 am to 2 pm. In addition to assisting with paper applications for voter registration, we will be distributing information about early and absentee (mail-in) voting. As we know, these are all critical components of this complex and challenging voting season. Voters need non-partisan and factual guidance today as much as in any time in our history.

We will be providing these same services at the Richland Park Farmer's Market on Saturdays from 9 am to 12 pm and the East Nashville Farmers' Market on Tuesdays from 3:30 to 6:30 pm. Two of our experienced registration volunteers, **Amy Kurland** and **Maureen Organ**, have tentatively scheduled **Saturdays** in September at the downtown **Farmers' Market on Rosa Parks Boulevard**. In all these undertakings, we are mindful of our responsibility to ourselves as well as the community with respect to **public health constraints** that govern us all. We trust that the event organizers who have invited our participation are equally committed to the safeguarding of everyone's health.

How pleased we are to be welcoming 12 new members who have joined the League and stepped right up to becoming voter services volunteers! Whether participating in these events or providing logistical support from 'behind the lines' as so many others are doing, please know how much your service is appreciated.

# The Impact of Covid-19 and the Economic Crash By Health Care Co-Chair Clare Sullivan

The COVID-19 Pandemic and Resulting Economic Crash Have Caused the Greatest Health Insurance Losses in American History. That is the title of a new report released this week by Families USA, a national healthcare advocacy organization. That report can be accessed at <a href="https://www.familiesusa.org/wp-content/uploads/2020/07/COV-254">https://www.familiesusa.org/wp-content/uploads/2020/07/COV-254</a> Coverage-Loss Report 7-14-20.pdf.

The report estimates that, as a result of layoffs related to Covid-19, **another 122,000** working-age Tennesseans have been added to the ranks of the uninsured, bringing the **total** number of **uninsured adults** in our state to **751,000**, or 19% of those aged 19-64. This also now moves our state into the **top ten** states in the nation for the number of uninsured non-elderly adults. The report underscores the **connection** between lack of health coverage and lack of care for underlying health conditions, delay in seeking attention for acute illnesses, and increased risk of complications or death from Covid infection.

There is legislation pending in Congress that can help address the growing gaps in health care coverage and access. The **Health and Economic Recovery Omnibus Emergency Solutions Act** or **HEROES** Act was passed by the House of Representatives in May. Majority Leader McConnell is being pressured to finally bring it before the Senate the week of July 20 when that body reconvenes. This legislation would do the following to address health care access:

- **increase** the federal contribution to states' Medicaid programs in exchange for agreement not to reduce current benefit levels;
- **open up** a special enrollment period on the ACA exchange so that uninsured do not need to wait until November to sign up for coverage;
- **give** states a new Medicaid option, with full federal funding for COVID-19 treatment for uninsured residents:
- **provide** additional stimulus investments.

The House of Representatives also passed legislation on **June 29** to **enhance** the **Affordable Care Act** to make coverage more affordable for all Americans lacking access to employer sponsored insurance. It is doubtful that this legislation will be brought before the Senate until the Supreme Court hears the case brought by Texas and

17 other state attorneys general (**including Tennessee**) this Fall. The Court's decision is not expected until **December** at the earliest. However, in November voters will have a chance to weigh in, as the bill **includes** many aspects of what is believed will be a large part of the Democratic health care platform. The bill would in brief:

- **Increase** the generosity of advanced premium tax credits available to low income households and reduce cost-sharing burden for households below 200% of the federal poverty level (FPL);
- Extend additional tax credits to households earning more than 400% of the FPL;
- Provide additional risk reinsurance payments to insurers, which would lower premiums for everyone
- **Enable** negotiation over drug prices to lower costs of care;
- **Provide** three years of 100% federal funding to incentivize states like Tennessee which have not yet expanded Tenneare (Medicaid) to childless low-income adults;
- **Remove** a 'glitch' in the original ACA to enable more families to enroll in Marketplace plans, even when a family member is offered employer-based insurance;
- **Provide** funding to support enrollment assistance and encourage enrollment.

The Republican proposal to replace the ACA, which the Trump administration has argued should be struck down in full, has not yet been revealed.

We encourage all readers of the Voter to do the following:

- Write, email, and/or call Senators Lamar Alexander and Marsha Blackburn this weekend or early next week to urge them to support the HEROES Act;
- Continue to write, email, and/or call your state representatives and Governor Lee asking their position on expanding coverage to low-income adults not now eligible for TennCare because they do not have children under 19;
- **Interact** with congressional candidates to understand their position on enhancing the ACA to make coverage available on the marketplace more affordable for more Americans;
- Consider the future of healthcare in our state and nation when you cast your ballot in August and in November.

State Advocacy Update - July By State Advocacy Co-Chair Debby Gould

Although the Legislative Session finally came to a crashing conclusion in the wee hours of **June 19**, advocacy activities for LWVTN did not end there. Earlier this month **LWVTN** sent a letter to members of the Tennessee Capitol Commission urging the **removal** of the Nathan Bedford Forrest bust from its place of honor in the capitol rotunda. We are pleased that the Commission **voted 7-2** to move the bust to the Tennessee State Museum but deeply disappointed that the two dissenting voices were individuals representing the Tennessee Senate and House, respectively.

Additionally, **LWVTN** filed an amicus brief for the appeal that will be heard in the Tennessee Supreme Court this summer regarding the **expansion** of absentee ballot access to voters during the threat of the Covid-19 pandemic. We share the firm conviction with our collaborative partnering organizations that personal safety and health should **not** be jeopardized in order to participate in an election.

News from Metro Government **By Metro Government Chair – Winnie Forrester** 

#### **Metro Nashville and Policing Reform**

George Floyd's murder and the call for deep systemic reforms have permeated every level of our society, not only in the United States, but across the world. In early June, along with 454 other organizations, the National League of Women Voters signed on to the Leadership Conference on Civil and Human Right's letter concerning federal policing priorities. The Leadership Conference is a coalition of more than 220 national organizations promoting and protecting civil and human rights in the United States. A copy of the letter can be found HERE.

As the Nashville chapter of the League, we pay close attention to **Metro Nashville's record on human rights**. In mid-June, Mayor Cooper announced that Metro's Police Chief, Steve Anderson, will step down after his replacement is determined by a national search. Numerous Councilmembers and community advocates had called for his resignation over the years, believing that he was an obstacle to meaningful reform. Advocates are hoping for a fresh face and not a promotion from within the police department.

At another marathon Metro Council meeting on July 7, the Council attempted to address systemic racism by introducing five bills relating to reform of policing practices. There are three readings held at separate Council meetings before a bill is officially passed. Typically, the first reading is a formality, and there is little discussion before the vote. The second reading includes a public hearing where comments from the public are heard. The third and last reading determines whether the bill will pass, and the 21 votes needed for passage can change dramatically from the previous meetings. The five bills are listed below:

#### **BILLS ON FIRST READING:**

Bill BL2020-329 which would prohibit the use of chemical weapons, including tear gas, by law enforcement.

Bill BL2020-330 gives citizens the right to ask an officer if their body camera is recording.

<u>Bill BL2020-331</u> would require that "every Metropolitan police officer who has any engagement with the public shall receive implicit bias training at least once per year using curriculum developed by the **Metropolitan Human Relations Commission.**"

#### **BILLS ON SECOND READING:**

Bill BL2020-322 prohibits the Metropolitan Nashville Police Department from hiring police officers from other law enforcement agencies who were previously fired or are under investigation for malfeasance or use of force.

Bill BL2020-323 had 18 councilmembers co-sponsor it. It requires de-escalation tactics such as verbal

warnings or advisements before resorting to force, intervention by other officers that may be present when another officer uses force when not reasonably necessary and prohibits chokeholds. Officers should also report any use of force against civilians when any civilian is injured, complains of injury in the presence of officers, or complains of pain continuing beyond the use of physical force.
