Vote411 Continued to Educate More Voters in 2020 By LWVN VOTE411 Coordinator Susan Mattson



VOTE411 – the LWV on-line election information and voter's guide – educated **more** voters than ever in 2020. Nationally, VOTE411 logged over 7.7 million sessions from January through Election day – a 141% increase from 2016 and a 20 % increase from 2018. LWVUS revamped the website in 2019 and worked tirelessly to add more candidates to the guide across the country in 2020. The LWVUS and Leagues across the country ramped up promotion of VOTE411 through social media posts and ads, news articles and ads, partnerships with other organizations, and billboards, among many others.

Vote 411 users continued to **grow** in Tennessee and Nashville. In 2020, **Tennessee** logged 65,589 user sessions; **Nashville** had 21,736. Nashville voters continue to be the primary users of VOTE411 in Tennessee - 32% of users with 10 percent of the voting population.

This September and October in the period leading up the Presidential election, 19,240 Tennesseans used VOTE411, a 42 % increase from the mid-term elections in 2018. Nashville's 9,130 users representing a 28 % increase from 2018. LWVUS expected only about a 20 % increase in users from 2018 to 2020, given that Tennessee and Nashville had already doubled its use of VOTE411 from 2016 to 2018.

Now that the national election saga has come to an end for the year, LWVN is turning its attention to the Tennessee General Assembly and their upcoming session in January 2021. The LWVTN State Advocacy Committee will meet on Monday, January 25, 11:30-12:30 p.m. We encourage any interested LWV member to join in these meetings to discuss high priority proposed legislation and determine the appropriate follow-up advocacy action by either our lobbyist Stewart Clifton, members of the Advocacy Committee, or the very best lobbyists of all — our statewide membership. Look for a zoom meeting invitation in January.

As a great kick-off in December, we had the opportunity to meet the newest member of the Davidson County delegation, **Senator Heidi Campbell**, representing District 20. During the presentation **LWVN** learned of her interest in quality public education, proactive steps to address climate change, improved access to healthcare, protection of LGBTQ rights, and expanding voting access. We also shared with her some of the ongoing **LWV** legislative priorities such as support for ex-felon voter restoration, opposition to school vouchers, and support for expanded healthcare coverage. 
What is New in Williamson County? By Linda Sherman

Summary of December Hot Topic – Vanderbilt Professor, James Blumstein Speaks on the Constitution and Presidential Powers **By Co-Vice President Ethel Detch**

As our nation struggles with the fallout of the November Presidential Election, our December Hot Topic could not have been timelier. **Dr. James Blumstein**, Vanderbilt University Professor of Constitutional Law and Health Law & Policy, spoke via Zoom on "Presidential Powers and the Constitution."

Professor Blumstein noted that for a constitution to work, a country must have a "culture of constitutionalism." In other words, the citizens must be willing to accept the constitution and abide by its rules and outcomes. **Self-restraint** is vital—otherwise, it becomes just words on paper. He added that a culture of constitutionalism must also have elements of **custom** and **practice.** In some cases, the constitution itself may not exactly spell out a practice, but the country develops traditions of practice for carrying out its provisions. These can be renegotiated, of course, but sometimes at great cost.

Professor Blumstein then turned specifically to Executive Powers in the Constitution, as well as the separation of powers. The US Constitution grants the President tremendous authority, some through inherent powers, but also enhanced by statute, as well as custom and practice. The President's powers, however, have been somewhat restrained through the **Uniform** Administrative Procedures Act, which was adopted shortly after World War II, to place parameters on the authority of executive branch departments.

Most 21st Century Americans would probably be surprised to learn that the US Constitution actually doesn't **mandate** that Presidents to be elected at all—the selection falls to each state's legislature. In the earlier years of our nation, there were no popular elections for the President. Today, however, all 50 states have elected to allow popular elections.

Questions followed Dr. Blumstein's remarks on wide-ranging topics such as Presidential pardons, the Electoral College, the power of the President to negotiate with other countries without the consent of Congress, and challenges to the US Census process.

The entire country is mesmerized as the first COVID -19 vaccine is introduced and distributed to the public. This is a cause for relief, considering all that the nation and the world has experienced since **March 2020**. Now we need to **ensure** that the medication is distributed appropriately and that, through public relations and education, citizens take advantage of its availability.

The country has also been pre-occupied with election politics and what appears to be the corroding of our democratic process. Perhaps with the **Electoral College** having cast its votes on Monday, we can settle down to a **peaceful** transition of presidential power.

As informed citizens, we must continue to focus on and stay abreast of those issues that have **never** gone away—issues affected by **long-term disparity** that cannot be addressed or solved with a pill or vaccine. While **COVID** has been in the forefront, people are continuing to die of **drug addiction** and **abuse**. The numbers have not decreased but appear to be on the rise. Nashville and Tennessee still have this malady to contend with. **Infant and Maternal mortality** still remains higher than that in many undeveloped countries.

Because of the pandemic, many people have lost health insurance, housing and the ability to work and pay bills. Our federal government continues to hassle over the cost of a stimulus package that would bring relief to those who are really in need. While we have been distracted, the current administration has reversed its stand on protecting Medicaid programs. It now allows states and legislatures to reduce or eliminate optional services like home health care, oral health care, substance use/abuse treatment, increase cost-sharing and even reduce benefit packages. This all during a pandemic. This ruling became effective immediately without the benefit of public comments.

COVID cases are continuing to rise and hospitalizations are on the increase with shortages of ICU beds becoming the norm in some areas. Deaths are increasing. Nashville and Tennessee have not been exempted. It will take awhile for the vaccine to produce its intended effect. We still need to be **vigilant** and **follow** the protective measures we have all been advised to observe. Let's continue to look at the entire health picture and **not forget** those issues that concerned us before March of this year.



The Cumberland River Compact By Environment Chair Barbara Gay

Election challenges and COVID 19 have us all distracted, but the **climate and environment** will be a major focus when these current problems are solved. It is comforting to know that the **Cumberland River Compact** is working in several areas to address environmental issues. Their goal and mission is:

"Three million people and thousands of species depend on clean water from the Cumberland River. We work on the root causes of water pollution, both urban and rural. Our goal is to give people the tools to be smart, impactful stewards of their watershed and to constructively partner within policy planning with government agencies. Through generous support from individuals, corporations, foundations, and grants, we are able to work on projects that positively impact our community. These projects are why we exist-and their results are what drive our mission and vision."

The Cumberland River Compact has **numerous projects** involving agriculture, riverbank stabilization, best management practices, climate resilience, dam removal, de-paving, environmental education, flood buyout, green alleys, green infrastructure, invasive removal, rain gardens, rainwater harvesting, river cleanup, schools, storm-water mitigation, stream restoration, teachers' curriculum, and tree planting.

News from Metro Government By Metro Government Chair Winnie Forrester

NEW TRANSPORTATION PLAN FOR NASHVILLE

Mayor Cooper's administration is proposing a new multi-modal transit plan, totaling \$1.6 billion over 10 years or more. Metro intends to pay for these improvements with annual capital budgeting and with state and federal grants. No public vote is required, because no tax is planned. (As a reminder, in 2018, Nashville voters rejected a \$9 billion mostly light-rail system that relied primarily on a modest sales tax increase.)

The plan's focus areas include **modernizing** the city's traffic management system, **upgrading** the WeGo bus system, investing in neighborhood infrastructure including sidewalks, bikeways, and greenways. The plan also has a focus on **improving** safety as a part of Mayor Cooper's Vision Zero Action Plan. You can read more of the top line details of the plan here and here, and the full 348-page plan is here.

On **December 15th**, the Council agenda includes a vote on a non-binding resolution, <u>RS2020-</u> 656, that expresses the Council's endorsement of the plan. The resolution also states that the plan may not be changed unless via the passage of another Council resolution and that the resolution is **not** an authorization to finance any portion of the plan and that any such request must be addressed by future legislation.
